The Governor's Office for Children, on behalf of the Maryland Children's Cabinet, recently announced the launch of an interagency strategic planning process that will enable Maryland to update and revise the 2008 Maryland Child and Family Services Interagency Strategic Plan (ISP). The Children's Cabinet is excited for the opportunity to mark Maryland's progress and address recommendations and strategies that continue to need our attention. All interested stakeholders - including family members, youth, children and youth advocates, child serving providers, and state and local agency staff - are invited and encouraged to participate in the planning process.

The following series of webinars will be posted throughout the months of October and November 2014, beginning with an orientation to the process, which includes a brief review of the 2008 plan, implementation updates, and the process for the 2014 update. The subsequent webinars relating to one or more of the ISP themes will be posted each Wednesday starting October 8, 2014, continuing through November 5, 2014.

Each webinar includes updates on progress made on the theme as well as presentation on best practices and activity around the nation. Each of these webinars contains a link to an online survey where you have the opportunity to provide specific input regarding the recommendations and strategies for that theme.
