## BALTIMORE CITY DEPARTMENT OF SOCIAL SERVICES ANNOUNCES TEMPORARY MODIFIED OPERATIONS IN RESPONSE TO COVID-19

BALTIMORE, MD (March 15, 2020) Starting Monday, March 16, 2020, all Baltimore City Department of Social Services (BCDSS) buildings will close to the public in order to promote social distancing and prevent further spread of the COVID-19 novel Coronavirus.

City residents and current BCDSS customers will be able to access needed services via telephone, websites, email and other ways that don't require inperson contact.

"This is a public health crisis—we must treat it as such," said Randi Walters, BCDSS Director. "At the same time, we must safely make sure the people in need can access the vital safety net services and benefits we provide without interruption."

Baltimore City Mayor Bernard C. "Jack" Young announced last week all evictions have been cancelled while public schools are closed. As such, the BCDSS Eviction Prevention Program office located in the District Court at 501 E. Fayette St. in Baltimore will be closed,
